

ORDINANCE NO. 8

AN ORDINANCE OF THE TOWN OF PORTAGE, INDIANA,
ANNEXING CERTAIN LAND HEREIN DESCRIBED TO SAID
TOWN.

BE IT AND IT HEREBY IS ORDAINED BY THE BOARD OF TRUSTEES
OF THE TOWN OF PORTAGE:

SECTION 1. That the territory hereinafter described, which
is located in the Township of Portage, Porter County, Indiana,
and which lies adjacent to the present limits of the Town of
Portage, shall be and the same hereby is annexed to the Town of
Portage, which territory is described by metes and bounds/as follows,
to-wit:

Beginning at a point on the Southerly boundary
line of the Town of Portage, which point is
specifically described as being located on the
South line of the right of way of the Indiana
East-West Toll Road and 20 feet West by rectangular
measurment from the North and South center line of
Section 18, Township 36 North, Range 6 West, in
Porter County, Indiana, and running thence South
on a line which is parallel to and 20 feet distant
West from the North and South center line of said
Section 18 and the North and South center line of
Section 19, Township 36 North, Range 6 West, to
its intersection with the East and West center line
of said Section 19; thence West on said East and
West center line of said Section 19 to a point which
is 330 feet West of the North and South center line
of said Section 19; thence South along a line which
is parallel to and 330 feet distant West from the
North and South center line of said Section 19 to the
South right of way line of United States Highway #6;
thence Easterly along said South right of way line
of the said United States Highway #6 a distance of
1190.6 feet, more or less, to a line which is parallel
to and 471.1 feet West of the East line of the North-
west Quarter of the Northeast Quarter of Section 30 *Twp 36, R 6*
thence South along said line which is parallel to and
471.1 feet West of the East line of the Northwest
Quarter of the Northeast Quarter of said Section 30,
a distance of 1316 feet, more or less, to the South
line of the Northwest Quarter of the Northeast Quarter

SECTION 1. That the territory hereinafter described, which

is located in the Township of Portage, Porter County, Indiana,

and which lies adjacent to the present limits of the Town of

Portage, shall be and the same hereby is annexed to the Town of

Portage, which territory is described by metes and bounds as follows,

to-wit:

Beginning at a point on the southerly boundary
line of the Town of Portage, which point is
specifically described as being located on the
South line of the right of way of the Indiana
East-West Toll Road and 20 feet West by rectangular
measurement from the North and South center line of
Section 18, Township 36 North, Range 6 West, in
Porter County, Indiana, and running thence South
on a line which is parallel to and 20 feet distant
West from the North and South center line of said
Section 18 and the North and South center line of
Section 19, Township 36 North, Range 6 West, to
its intersection with the East and West center line
of said Section 19; thence West on said East and
West center line of said Section 19 to a point which
is 230 feet West of the North and South center line
of said Section 19; thence South along a line which
is parallel to and 230 feet distant West from the
North and South center line of said Section 19 to the
South right of way line of United States Highway #6;
thence Easterly along said South right of way line
of the said United States Highway #6 a distance of
1190.6 feet, more or less, to a line which is parallel
to and 471.1 feet West of the East line of the North-
west Quarter of the Northeast Quarter of Section 30,
thence South along said line which is parallel to and
471.1 feet West of the East line of the Northwest
Quarter of the Northeast Quarter of said Section 30,
a distance of 1316 feet, more or less, to the South
line of the Northwest Quarter of the Northeast Quarter

North right of way line of United States Highway No. 6 a distance of 1948 feet, more or less, to a line which is parallel to and 1029 feet East of the North and South center line of Section 19, Township 36 North, Range 6 West; thence North at right angles the distance of 622.3 feet; thence West at right angles a distance of 214.6 feet, more or less, to a line parallel to and 484.0 East of the North and South center line of said Section; thence North along said parallel line to the East and West center line of said Section 19; thence West along said East and West center line of Section 19 to a point which is located on said East and West center line 20 feet East from the North and South center line of said Section 19; thence North along a line which is 20 feet distant East from and parallel to the said North and South center line of said Section 19 and a line which is 20 feet distant East from and parallel to the North and South center line of Section 18, Township 36 North, Range 6 West to the point where the same intersects the South line of the Town of Portage, the same being also the South boundary line of the right of way of the Indiana Toll Road; thence Westerly along the South right of way of the said Indiana East-West Toll Road to the point of beginning.

SECTION 2. A certified copy of this Ordinance shall be conclusive evidence in any proceeding that the territory herein described has been properly annexed to and constitutes a part of the Town of Portage, Indiana.

SECTION 3. The Clerk-Treasurer of the Town of Portage is hereby directed to prepare a certified copy of this Ordinance and deliver the same to the Auditor of Porter County, Indiana, forthwith.

SECTION 4. This ordinance shall be in full force and effect from and after its passage.

SECTION 5; The Clerk-Treasurer is ordered to cause copies of this ordinance to be published in the Portage News and in The Vidette Messenger.

North right of way line of United States Highway No. 6 a distance of 1948 feet, more or less, to a line which is parallel to and 1020 feet East of the North and South center line of Section 18, Township 36 North, Range 6 West; thence North at right angles the distance of 622.3 feet; thence West at right angles a distance of 214.6 feet, more or less, to a line parallel to and 484.0 East of the North and South center line of said Section; thence North along said parallel line to the East and West center line of said Section 18; thence West along said East and West center line of Section 18 to a point which is located on said East and West center line 20 feet East from the North and South center line of said Section 18; thence North along a line which is 20 feet distant East from and parallel to the said North and South center line of Section 18 and a line which is 20 feet distant East from and parallel to the North and South center line of Section 18, Township 36 North, Range 6 West to the point where the same intersects the South line of the Town of Fortage, the same being also the South boundary line of the right of way of the Indiana Toll Road; thence Westerly along the South right of way of the said Indiana East-West Toll Road to the point of beginning.

SECTION 2: A certified copy of this Ordinance shall be

conclusive evidence in any proceeding that the territory herein described has been properly annexed to and constitutes a part of the Town of Fortage, Indiana.

SECTION 3: The Clerk-Treasurer of the Town of Fortage is

hereby directed to prepare a certified copy of this Ordinance and deliver the same to the Auditor of Porter County, Indiana, forthwith.

SECTION 4: This ordinance shall be in full force and effect

from and after its passage.

SECTION 5: The Clerk-Treasurer is ordered to cause copies of

this ordinance to be published in the Fortage News and in The Vidette
