ORDINANCE NO. 25

AN ORDINANCE OF THE TOWN OF PORTAGE CREATING THE OFFICE OF BUILDING COMMISSIONER, PROVIDING FOR A BOND OF SAID COMMISSIONER, AND PRESCRIBING THE DUTIES OF SUCH OFFICE.

BE IT AND IT HEREBY IS ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PORTAGE;

SECTION 1. There is hereby created and continued in the Town of Portage, Porter County, Indiana, the Office of Building Commissioner. The person to fill such office shall be appointed by the Board of Trustees of said Town, subject to removal at their pleasure. In all matters relating to the duties of his office, as hereinafter set out, the Building Commissioner shall be under the supervision, direction and control of the Board of Trustees, unless herein otherwise expressly stipulated.

SECTION 2. Before any Building Commissioner shall enter upon his duties he shall take and subscribe to an oath of office upon the back of his certificate of appointment, and file bond in the sum of \$1,000.00 payable to the Town of Portage to be approved by the Board of Trustees conditioned upon the faithful performance of his duties. The premium for said bond shall be paid by the Town of Portage, if a Surety Company bond is used.

SECTION 3. It shall be the duty of said Building Commissioner to approve all building permits in accordance with the provisions of this Ordinance and to have charge of and enforce all ordinances now in force or which may hereafter be established, together with all Town, State and Federal laws and regulations pertaining to the erection, construction, alteration, repair

AN ORDINANCE OF THE TOWN OF PORTAGE CREATING THE

SECTION 1. There is hereby created and continued in
the Town of Portage, Porter County, Indiana, the Office of Building

hereinafter set out, the Building Commissioner shall be under the

gether with all Town, State and Federal laws and regulations per-
taining to the erection, construction, alteration, maintenance and

Whenever violation of or failure to comply with any ordinance of the Town of Portage, or any State or Federal law or regulation comes to the attention of the Building Commissioner he shall take all steps necessary to enforce the applicable provisions of the pertinent ordinances, laws and regulations. For the purpose of carrying out his duties the Building Commissioner shall have the right at all reasonable times to enter buildings and premises in the Town of Portage for the purpose of inspecting the same and ascertaining whether or not applicable ordinances, laws and regulations are being complied with. *He shall appoint as assistants an electrician inspector, a plumbing inspector and a building inspector.*

SECTION 4. That Floyd Norris be and he hereby is appointed

Building Commissioner of the Town of Portage, Porter County, Indiana.

Building Commissioner of the Town of Portage, Porter County, Indiana.

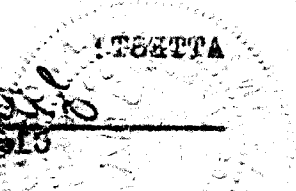
