

ORDINANCE NO. 68-32

"AN ORDINANCE OF THE CITY OF PORTAGE, INDIANA, ESTABLISHING A CUMULATIVE BRIDGE FUND FOR THE PURPOSE OF BUILDING AND REPAIR OF BRIDGES."

WHEREAS, by resolution adopted July 15, 1968, the Common Council of the City of Portage proposed the establishment of a cumulative bridge fund for the purpose of building and repair of bridges, and

WHEREAS, hearing on the establishment of said cumulative fund was set for the 29th day of July, 1968, and

WHEREAS, the taxpayers of said city were given notice of such hearing as required by law, and

WHEREAS, said public hearing was held on the 29th day of July, 1968, and

WHEREAS, no remonstrance to the establishment of said cumulative fund has been filed;

NOW, THEREFORE, BE IT AND IT HEREBY IS ORDAINED by the Common Council of the City of Portage, Indiana, as follows:

1. That there be established a cumulative bridge fund for the purpose of building and repair of bridges and that there be levied an additional tax at the rate of Five cents (5 ¢) on each One Hundred Dollars (\$100.00) of taxable property in the City of Portage, Porter County, Indiana, to provide funds for said fund, said tax to be first levied in the year 1968, payable in the year 1969, and annually thereafter for a period of Five (5) years, all as provided by the Acts of 1951 of the Indiana General Assembly, Chapter 299, Section 1.

2. This Ordinance shall be in full force and

NOW, THEREFORE, BE IT ENACTED BY

the Common Council of the City of Portage, Indiana, as follows:

1. That there be established a cumulative bridge

fund for the purpose of building and repair of bridges and

that there be levied an additional tax at the rate of five

cents (5) on each one hundred dollars (\$100.00) of taxable

property in the City of Portage, Porter County, Indiana, to

provide funds for said fund; said tax to be first levied in

the year 1968, payable in the year 1969, and annually there-

after for a period of five (5) years, all as provided by

the acts of 1951 of the Indiana General Assembly, Chapter

299, Section 1.

2. This Ordinance shall be in full force and
