

ORDINANCE NC. 68-34

"AN ORDINANCE OF THE CITY OF PORTAGE, INDIANA, ESTABLISHING A CUMULATIVE BUILDING AND EQUIPMENT FUND FOR THE PURPOSE OF THE ERECTION OF FIRE STATIONS AND/OR THE ERECTION OF ADDITIONS TO AND THE REMODELING OF THE PRESENT BUILDINGS USED TO HOUSE FIRE FIGHTING EQUIPMENT AND FOR THE PURCHASE OF FIRE FIGHTING EQUIPMENT."

WHEREAS, by resolution adopted July 15, 1968, the Common Council of the City of Portage proposed the establishment of a cumulative building and equipment fund for the purpose of the erection of fire stations and/or the erection of additions to and the remodeling of the present buildings used to house fire fighting equipment and for the purchase of fire fighting equipment, and

WHEREAS, hearing on the establishment of said cumulative fund was set for the 29th day of July, 1968, and

WHEREAS, the taxpayers of said city were given notice of such hearing as required by law, and

WHEREAS, said public hearing was held on the 29th day of July, 1968, and

WHEREAS, no remonstrance to the establishment of said cumulative fund has been filed;

NOW, THEREFORE, BE IT AND IT HEREBY IS ORDAINED by the Common Council of the City of Portage, Indiana, as follows:
