AN ORDINANCE OF THE CITY OF PORTAGE,
AMENDING ORDINANCE NO. 54, ENTITLED,
"ZONING ORDINANCE OF THE CITY OF PORTAGE,
INDIANA, 1960, ORDINANCE NO. 54."

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Portage, Indiana, as follows:

SECTION 1. Ordinance No. 54, of the City of Portage, shall be Amended in the following particulars:

A. Section 25, Filing Fees, paragraph B as amended, shall be further Amended, by adding:

"For each petition to the Board of Zoning Appeals, for a Variance from the Ordinance, a Fee of Twenty-five dollars (\$25.00) is to be paid to and collected by the City Clerk-Treasurer, the receipt of which shall accompany the petition."

B. Section 25, Filing Fees, paragraph C as amended, shall be further Amended, as follows:

"For each petition to the Board of Zoning Appeals, for a Special Exception, a Fee of Twenty-five dollars (\$25.00) is to be paid to and collected by the City Clerk-Treasurer, the receipt of which shall accompany the petition."

SECTION 2. This Amendment shall become effective immediately upon its enactment and passage by the Common Council of the City of Portage, Indiana.

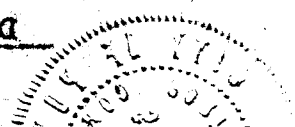
