AN ORDINANCE OF THE CITY OF PORTAGE AMENDING ORDINANCE NO. 54, ENTITLED, "ZONING ORDINANCE OF THE CITY OF PORTAGE, INDIANA, 1960, ORDINANCE NO. 54."

BE IT AND IT HEREBY IS ORDAINED by the Common Council of the City of Portage, Indiana, under Authority of Chapter 174, of Acts of the General Assembly of the State of Indiana, 1947, and all Acts Amendatory thereto:

SECTION ONE. Section 20, Figure 7, Contingent Uses and Requirements on page 52, of Ordinance 54, shall be Amended by deleting NURSING HOMES AND HOMES FOR THE AGED and the accompanying requirements.

SECTION TWO. Section 20, Figure 9, Special Exceptions and Requirements on page 53, of Ordinance 54, shall be Amended by adding and including NURSING HOMES AND HOMES FOR THE AGED, with the accompanying requirements of A-3, (A being the classification of use permitted, 3 being an addition of COMMERCIAL PLUS R-3,) C-8, G, H-1, K-9, O, P & V.

SECTION THREE. This Amendment shall become effective immediately upon its enactment and passage by the Common Council of the City of Portage, Indiana.

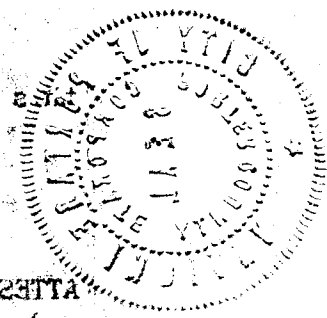
SECTION ONE. Section 20, Figure 7, Contingent Fees and Reimbursements on



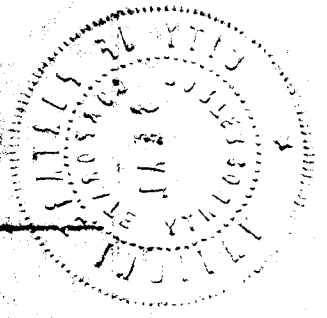
